The Government of Uganda has received financing from the World Bank toward the cost of the Competitiveness and Enterprise Development Project (CEDP), and intends to apply part of the proceeds toward payments under the contract for Supply and Delivery of Assorted Furniture and Furnishing Items packaged as follows:
5. The Bidding Document in English may be purchased by interested Bidders upon submission of a written application to the address in No. 8 and upon payment of a non-refundable fee of UGX: 100,000 (Uganda Shillings One hundred thousand only) or its equivalent in a freely convertible currency using the exchange rate published by Bank of Uganda on the date of payment. The method of payment will be by cash/ EFT. EFT payments in foreign currency should include an additional USD 20 or its equivalent to cater for Bank Charges. Bidders may make arrangements with courier service providers to have the bidding Document delivered to them. However, PSFU-CEDP shall not accept liability for loss or late delivery.

6. Bids must be delivered to the address in No. 8 by **11:00am** on or before **September 9, 2022**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives who choose to attend at the address below at 11:05am on September 9, 2022 .
7. All Bids must be accompanied by a Bid Security in Uganda Shillings or its equivalent in a freely convertible currency using exchange rates published by Bank of Uganda on the date of issue of the security, as follows:
